(together, the "Selling Stockholders") for an aggregate price of \$105,134,811.54 (the "Repurchase"). In connection with the Repurchase, the Selling Stockholders are converting an aggregate 14,622,366 shares of Class B Common Stock ("Class B Shares") into Class A Shares on a one-for-one basis.
- 2. Francisco Partners GP IV, L.P. ("Francisco Partners IV-A, L.P. ("Francisco Partners IV-A). Francisco Partners GP IV Management Limited is the general partner of Francisco Partners GP IV Management, L.P. ("Francisco Partners Management") serves as the investment manager for each of Francisco Partners IV and Francisco Partners IV-A. Voting and disposition decisions at Francisco Partners Management timited is the general partner of Francisco Partners Management, L.P. ("Francisco Partners Management") serves as the investment manager for each of Francisco Partners IV and Francisco Partners IV-A.
